

# What is the objective of the Plan?

#### OBJETIVE



- By 2015, to halt and begin to reverse the spread of HIV/AIDS as well as STI in the Region by providing *universal access to prevention, care, and treatment* 

#### **OVERALL TARGETS**

- By 2010, there will be a 50% reduction in the estimated number of new HIV infections followed by a further 50% reduction in new infections by the end of 2015
- By 2010, there will be universal access to comprehensive care including prevention, care and antiretroviral treatment.
- By 2015, incidence of mother-to-child transmission on HIV will be less than 5% and incidence of congenital syphilis will be less than 0.5 cases per 1000 live births

#### **OTHER TARGETS AND MILESTONES**

- 74 targets and milestones will assist countries in monitoring the Plan

"Countries in Latin America have been taking an increasingly aggressive stance towards the pharmaceuticals industry over patented Aids treatments, which could set a pattern for other developing nations".

"The prices they have achieved are in some cases lower than in sub-Saharan Africa," says James Fitzgerald, a drug procurement specialist at the Pan American Health Organization in Washington".







As the year 2015 approaches, we still have a long way to go to show impact on the Millennium Development Goals (MDGs) indicators:




- Prevalence of HIV infection in pregnant women 15-24

### Estimated N· of People with HIV (Adults & Children) in LAC, 1980-2015 (Middle Scenario)





# Impact of the Reduction in New HIV Infections on the No of people with HIV: 2005-2015






# Impact of the Reduction in New HIV Infections on ART Needs: 2005-2015





Collaboration in definition of youth-friendly health services
Involving teachers in fight against stigma & discrimination

## Opportunities for collaboration Labor sector

Promote workplace policies:

- To eliminate discrimination
- To include measures to ensure implementation
- To protect the rights and health of workers
- To reduce risks (e.g. condom provision)
- To improve treatment coverage, adequacy & comprehensiveness of services (e.g. PEP)
- To assure gender-sensitivity of programs





## Opportunities for collaboration Labor sector

• Workplace as entry point for HIV education on prevention, including on voluntary counseling & testing (communications campaigns)

Incorporate HIV in ongoing training programs

•Tripartite engagement in national AIDS activities, including arrangements to sustain long-term provision of therapy

•Key location for actions to reduce stigma & discrimination

Participation in national AIDS bodies and CCMs

•Follow up to the ILO/UNAIDS Consultation (*Recent May 2006, Brasilia Meeting*)

## Opportunities for collaboration Social Security sector


 Integrate workers' health into social security plans
