1. PLANNING / IDENTIFICATION OF COOPERATION ACTIVITY

- Internal Process: Identify institutional priorities that require cooperation TODAY.

2. IDENTIFY THE RIGHT PARTNER (MINISTRY OF LABOR)

- RIAL Focal Points
- Workshops or Seminars
- Portfolio of Programas
- Technical Secretariat / OAS

3. PRESENTATION OF PROPOSAL AND SELECTION PROCESS

- Focal Point centralize and send proposal
- Formal submission through Permanent Missions to the OAS

4. CARRYING OUT ACTIVITY AND FUNDING

- Between June and December 2017
- OAS coordinates and facilitates – Working together
- Determining agenda – very important



5. FINAL REPORTS

- Specific Requirements – critical appropriation / steps to follow
- Important to follow RIAL report form

6. FOLLOW-UP

- 6 months later
- Based in steps to follow and conclusions from the Final Report

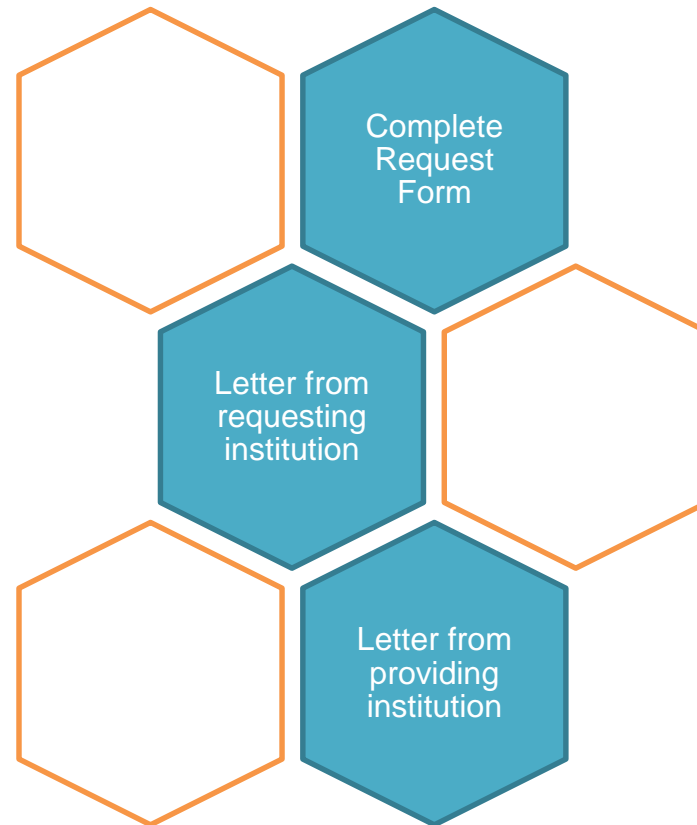

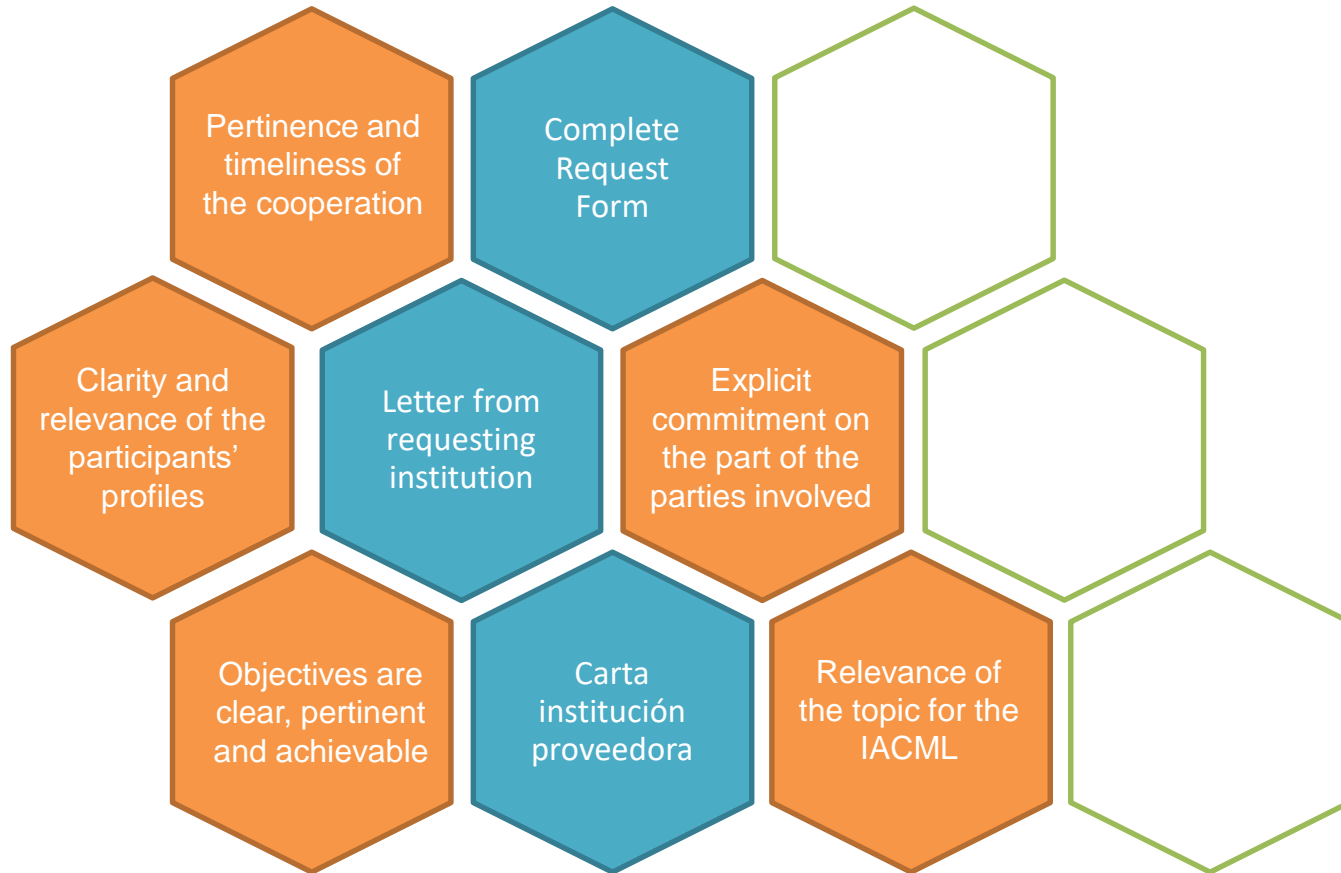

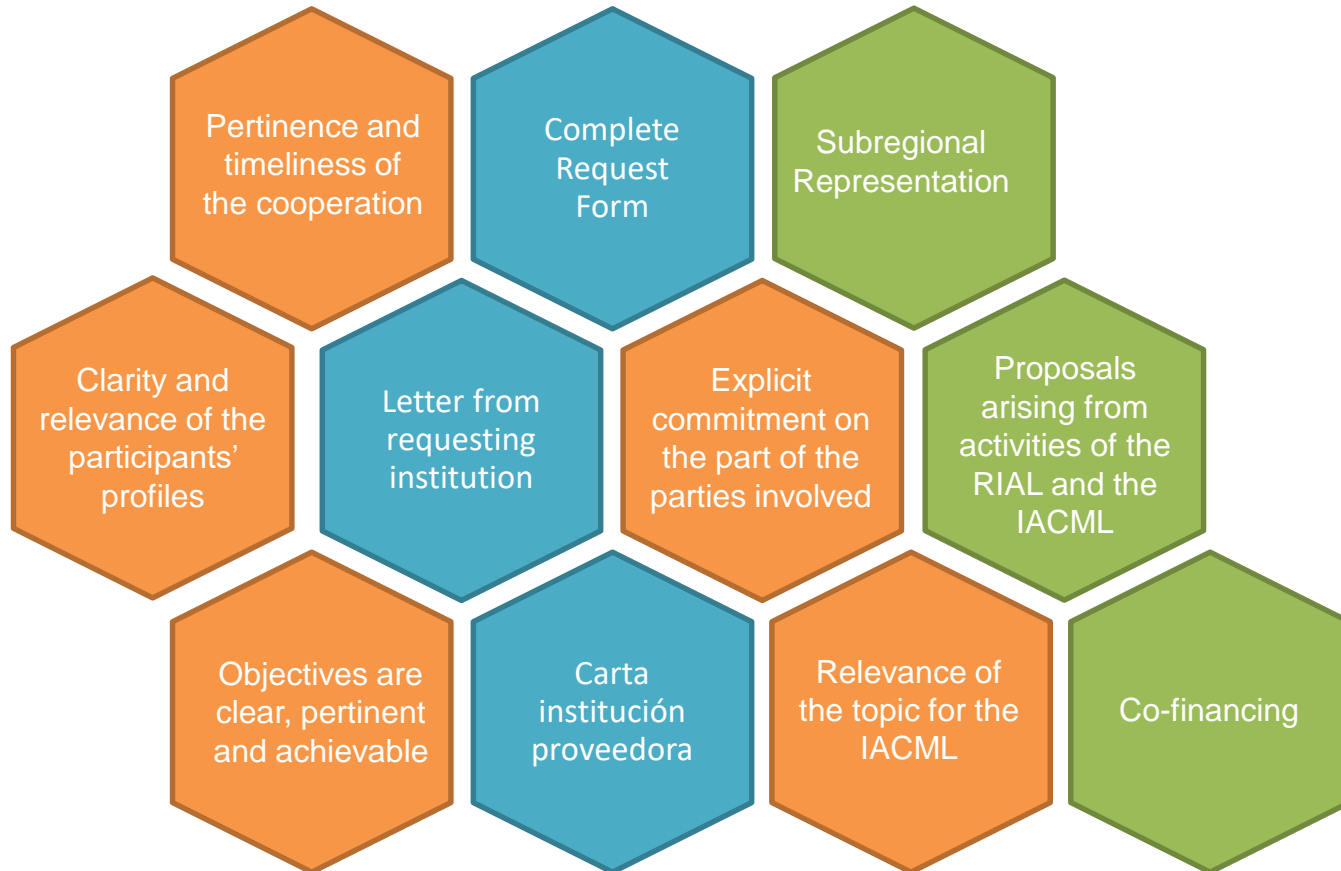
