This Workshop has been organized in response to the strategic guidelines on gender approved by the XV IACML, and will provide a forum for discussion of the study "The Institutionalization of a Gender Approach in the Ministries of Labor of the Americas". This study was also conducted in response to the strategic guidelines and was based on a broad questionnaire sent to the Ministries, and completed by the gender specialized units or by the officers with that responsibility.

Participants: Officers from the Ministries of Labour in charge of the gender area, that answered the questionnaire, representatives from COSATE and CEATAL, and international organizations relevant to the IACML.

Registration: Participants must fill out the Registration Form enclosed to this bulletin and send it to the IACML Technical Secretariat, as soon as possible.

Funding: The OAS, with funding provided by the Canadian Government, will cover travel expenses (airplane fare and per diem) for some representatives from Ministries of Labor of smaller economies, 2 COSATE representatives and 2 CEATAL representatives.

Those officials who would like to receive funding should indicate it in the Registration Form and send it as at their earliest convenience and not later than <u>July 1, 2009</u>. The OAS will analyze the requests on a first-come first-serve basis and confirm each participant's funding as soon as possible.
